We are aware of the importance of personal data protection and privacy of our customers, and therefore the storage and processing of your personal data is governed by applicable laws, especially the Act No. 101/2000 Coll., on the Protection of Personal Data, Act No. 127/2005 Coll. on Electronic Communications, as well as by the relevant provisions of the Civil Code and the relevant standards of the European Union. These laws are a foundation of our Terms and Conditions for the processing of personal, personally identifying and operational data of our customers, which can be found on the company website.

Why We Process Your Personal Data

Providing personal data is voluntary, however business contracts and fulfilment of obligations requires some of your data. The primary purpose of the information you give us, is providing our services and products, as well as our internal use for marketing and commercial purposes or for debt collection and evaluation of payment history. For the summary of the data we are entitled to process by law, as well as the information about the data whose processing can be refused, please see the Processed Data document. If you decide to refuse the processing of certain data, you can do so simply by sending an e-mail to office@topstone.cz or by a written notification sent to our address.

To Whom Can The Data Be Provided

For some activities, such as marketing activities, debt collecting etc., we work together with third parties that need access to certain data. To do so, we need to ask for your consent in some specific cases. Please see the Processed Data document for the summary of the data, that is provided to third parties according to the law, as well as the data that require your consent to be provided. When providing your personal data to third parties, we always pay attention to ensure that data is provided only to the extent necessary and to trusted entities that are committed to properly and securely protect the data.

We are also required to provide the processed Data in cases specified by law, e.g. to governmental authorities, courts, law enforcement authorities in criminal proceedings, etc.

We place great emphasis on security policy within the company, employee confidentiality,


